Youth in our community are experiencing homelessness and many more are at-risk, living in dangerous situations, in cars, or couch surfing. Other young people are aging out of state care, identify as LGBTQ+, and/or have no supports. They all are susceptible to sexual violence and human trafficking. Youth Continuum, with a cadre of caring partners, provides vital programs to keep 12-24-year-olds safe including emergency shelter, housing options, and services that help them transition to independent adults.

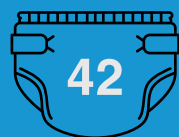
